Avoid embankements and other areas of rough or unstable ground.. - Effective 5) CRITICAL - Administrative: Always carry a charged mobile phone for communication.. - Effective 6) CRITICAL - Administrative: Naked flames are not to be used in the presence of any highly flammable materials such, as paints, solvents and gases.. - Effective 7) CRITICAL - Administrative: Do not enter confined spaces or any tunnels.. - Effective 8) CRITICAL - Administrative: If work is required on or near the running line on an operational day inform the signalman at either end of the section.. - Effective 9) CRITICAL - Administrative: Lone working is only allowed in daylight.. - Effective 10) CRITICAL - Administrative: If a ladder or scaffold is to be used, call another member of staff at the start and end of the task and inform them of the expected duration of working at height.. - Effective 11) CRITICAL - PPE: Wear appropriate PPE for the task.. - Effective 12) CRITICAL - PPE: Always wear Hi-Viz clothing.. - Effective | 2 x 2 = 4 | 2 = 4 | None | Low - Risk to be monitored to ensure it remains adequately controlled to an acceptable level. | 2 x 2 = 4 | n/a |
