**A group of young people visit an operational signal box**

Operations	The signalman on duty becomes distracted and causes an incident. This can happen when the behaviour of the young people is poor or they try to talk to the signalman while the signalman is dealing with a train.	Everyone	1) CRITICAL - Administrative: Young people to be given safety briefing before starting activity - Effective 2) CRITICAL - Administrative: An off duty signalman to accompany the group and manage the behaviour of the young people. - Effective 3) CRITICAL - Administrative: No young people under the age of 14 permitted to take part in box visits. - Effective 4) CRITICAL - Administrative: Limit of 6 young people per visit. - Effective	1 x 4 = 4 Low - Risk to be monitored to ensure it remains adequately controlled to an acceptable level. Health and Safety	A young person gets too close to a train or otherwise causes an incident and / or injures themselves while walking trackside. Some signal boxes can only be accessed by going trackside, this can happen when poor PTS practice is followed by the young people. Breach of Law or Regs	A breach of safeguarding protocol occurs. This can happen when safeguarding practice is incorrectly followed or not followed at all.
