P210 - Keep away from heat, hot surfaces, sparks, open flames and other ignition sources. No smoking.
P233 - Keep container tightly closed.
P260 - Do not breathe dust/fume/gas/mist/vapours/spray.
P303 + P361 + P3 - IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water [or shower].
P308 + P313 - IF exposed or concerned: Get medical advice/attention.
P370 + P378 - In case of fire: Use... to extinguish.
P501 - Dispose of contents/container via an approved disposal route

Control Measures

Current:

- Administrative - Follow manufacturers advice. - Effective

Potential:

- Engineering - Consider fume extraction in poorly ventilated areas. - Effective
- PPE - Consider wearing a mask - Effective
