Health Phrases

H225 - Highly flammable liquid and vapour.
H315 - Causes skin irritation.
H318 - Causes serious eye damage.
H361 - Suspected of damaging fertility or the unborn child <state specific effect if known>
H336 - May cause drowsiness or dizziness.
H373 - May cause damage to organs <or state all organs affected, if known> through prolonged or repeated exposure.
H304 - May be fatal if swallowed and enters airways.
H411 - Toxic to aquatic life with long lasting effects.

Precautionary Phrases

P241 - Use explosion-proof equipment.
P242 - Use non-sparking tools.
P243 - Take action to prevent static discharges.
P260 - Do not breathe dust/fume/gas/mist/vapours/spray.
P264 - Wash thoroughly after handling.
P271 - Use only outdoors or in a well-ventilated area.
P273 - Avoid release to the environment.
P280 - Wear protective gloves/protective clothing/eye protection/face protection.
P301 + P310 - IF SWALLOWED: Immediately call a POISON CENTER/doctor/999
P303 + P361 + P3 - IF ON SKIN (or hair): Take off immediately all contaminated clothing. Rinse skin with water [or shower].
P304 + P340 - IF INHALED: Remove person to fresh air and keep comfortable for breathing.
P305 + P351 + P3 - IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.
P308 + P313 - IF exposed or concerned: Get medical advice/attention.
P331 - Do NOT induce vomiting.
P332 + P313 - If skin irritation occurs: Get medical advice/attention.
P362 - Take off contaminated clothing.
P370 + P378 - In case of fire: Use... to extinguish.
P391 - Collect spillage.
P403 + P233 - Store in a well-ventilated place. Keep container tightly closed.
P403 + P235 - Store in a well-ventilated place. Keep cool.
P405 - Store locked up.
P501 - Dispose of contents/container via an approved disposal route
